# Foreword by the CEO

Dear shareholders, dear business partners, ladies and gentlemen, let me briefly evaluate the activities and results of Servodata a.s. (hereinafter referred to as "Servodata") in fiscal year 2018.

The year 2018 was full of demanding challenges for Servodata, consisting mainly in strengthening technical competencies and expanding the portfolio of services. With regard to the lack of working capital on the Czech market, in addition to natural growth, we were also looking for an entity to acquire that would accelerate our growth. Although we have identified interesting targets and have reached a very advanced stage of negotiation, none of the transactions under consideration have been completed this fiscal year. Nevertheless, we managed to expand our competencies in the field of services, especially in the field of IT consulting. It is worth mentioning the competence in optimizing IT costs for our clients, the area of security, or the area of HW and SW infrastructure and, last but not least, the area of open source solutions. The focus on the delivery of services and products is in line with Servodata's strategy, which is changing from a license distributor to a specialized supplier of professional IT services with a focus on high added value. At the same time, this year we started creating new products that are not only technologically advanced, but also have a social dimension. It is a wearable device supported by the control room. The product is designed for social service providers with a view to scaling products to foreign markets. Servodata has also expanded its product line with a personal data management application that responds to the requirements of the GDPR Regulation. The application is designed primarily for public administration environments.

Within this year, we managed to successfully implement a number of complex projects combining our entire portfolio of competencies. In fiscal year 2018, the company invested intensively in new products and services, the profits of which will be realized in the following accounting periods. However, this investment was desirable from the perspective of the future development of the company, even at the cost of a slightly negative economic result in fiscal year 2018.

I am still pleased that an open corporate culture and common values bring the right energy to our company, which positively affects not only overall cooperation, personal responsibility and innovation.

Thank you to all our customers and business partners for their long-term trust. I also thank all my colleagues, whose efforts and results I appreciate very much. I look forward to the further challenges that 2019 will bring us.


### THE ROLE OF THE COMPANY IN THE GROUP AND THE METHOD AND MEANS OF CONTROL
